FOSTER AND SHELTER PROGRAMS: OUR FOSTER AND SHELTER PROGRAMS REACHED A MILESTONE OF SAVING AND FACILITATING ADOPTIONS FOR OVER 1,000 CATS IN 2016. COMBINED, THESE TWO PROGRAMS TOOK IN 1,189 CATS AND FACILITATED ADOPTIONS FOR RESULTING IN A 47% INCREASE OVER PRIOR YEAR RESULTS. BOTH PROGRAMS INCREASED PULLS FROM ANIMAL CONTROL AGENCIES BY NEARLY 200% OVER PRIOR YEAR. ALL CATS WERE SPAYED OR NEUTERED, VACCINATED, TESTED FOR FIV/FELV, MICROCHIPPED, AND TREATED FOR PARASITES. IN ADDITION, 9 CATS WERE REUNITED WITH THEIR OWNERS.

SPAY/NEUTER OUTREACH PROGRAM: THIS PROGRAM PROVIDES SUPPORT SERVICES FOR COMPANION CATS AND CATS LIVING IN DIFFICULT SITUATIONS, INCLUDING FERAL CAT COLONIES. THE PRIMARY FOCUS OF THIS PROGRAM IS TO PREVENT UNWANTED LITTERS BY PROVIDING LOW COST SPAY/NEUTER SERVICES AND SUPPORTING AND PRACTICING TRAP, NEUTER, RETURN, (T/N/R). EFFORTS IN 2016 RESULTED IN THE STERILIZATION OF 1,045 HOMELESS AND COMPANION CATS. THIS PROGRAM DISTRIBUTED FOOD, LITTER, AND COMMUNITY CAT SHELTERS IN SUPPORT OF OWNED CATS AND OUTDOOR COMMUNITY CAT CARETAKERS. IN ADDITION THIS PROGRAM PROVIDED \$10,695 IN MEDICAL TO OWNERS WHOSE CATS WERE IN NEED OF MEDICAL ATTENTION, AND TRANSFERRED \$5,000 TO EACH OF FELINE RESCUE'S OTHER TWO PROGRAMS TO ASSIST WITH MEDICAL NEEDS OF PROGRAM CATS. OUTREACH VOLUNTEERS
