**FOSTER & SHELTER: OUR FOSTER AND SHELTER PROGRAMS SERVED A RECORD NUMBER OF CATS THIS YEAR. WE TOOK IN 664, AN INCREASE OF 164 OVER 2013 AND 592 WERE ADOPTED, AN INCREASE OF 171 OVER 2013. ALL CATS WERE VACCINATED, TESTED FOR FIV/FEL, MICROCHIPPED AND TREATED FOR PARASITES. IN ADDITION, THE OWNERS OF 3 CATS WERE LOCATED AND REUNITED WITH THEIR CATS.**

**SPAY/NEUTER OUTREACH PROGRAM: THIS PROGRAM PROVIDES SUPPORT SERVICES FOR COMPANION CATS AND CATS LIVING IN DIFFICULT SITUATIONS, INCLUDING COLONIES OF FERALS. THE PRIMARY FOCUS OF THIS PROGRAM IS TO PREVENT UNWANTED LITTERS BY PROVIDING LOW COST SPAY/NEUTER SERVICES. OUR EFFORTS RESULTED IN THE STERILIZATION OF 787 COMPANION AND HOMELESS ANIMALS, AN INCREASE OF 122 OVER THE PREVIOUS YEAR.
