**OUR FOSTER AND SHELTER PROGRAMS SAVED AND FACILITATED ADOPTIONS FOR OVER 1,000 CATS IN 2018. COMBINED, THESE TWO PROGRAMS TOOK IN 970 CATS AND FACILITATED ADOPTIONS FOR 1,070. ALL CATS WERE SPAYED OR NEUTERED, VACCINATED, TESTED FOR FIV/FELV, MICROCHIPPED, AND TREATED FOR PARASITES. IN ADDITION, 7 CATS WERE REUNITED WITH THEIR OWNERS. **THIS PROGRAM PROVIDES SUPPORT SERVICES FOR COMPANION CATS AND CATS LIVING IN DIFFICULT SITUATIONS, INCLUDING FERAL CAT COLONIES. THE PRIMARY FOCUS OF THIS PROGRAM IS TO PREVENT UNWANTED LITTERS BY PROVIDING LOW-COST SPAY/NEUTER SERVICES AND SUPPORTING AND PRACTICING TRAP, NEUTER, RETURN (T/N/R). EFFORTS IN 2018 RESULTED IN THE STERILIZATION OF 1,682 HOMELESS AND COMPANION CATS, A 16% INCREASE FROM 2017, HELPING OVER 26 RESCUE ORGANIZATIONS AND MANY INDIVIDUALS ACROSS THE STATE OF MINNESOTA AND IN WESTERN WISCONSIN.
