SPAY/NEUTER OUTREACH PROGRAM

THIS PROGRAM PROVIDES SUPPORT SERVICES FOR COMPANION CATS AND CATS LIVING IN DIFFICULT SITUATIONS, INCLUDING FERAL CAT COLONIES. THE PRIMARY FOCUS OF THIS PROGRAM IS TO PREVENT UNWANTED LITTERS BY PROVIDING LOW-COST SPAY/NEUTER SERVICES AND SUPPORTING AND PRACTICING TRAP, NEUTER, RETURN (T/N/R). EFFORTS IN 2019 RESULTED IN THE STERILIZATION OF 615 HOMELESS AND COMPANION CATS, HELPING RESCUE ORGANIZATIONS ACROSS THE STATE OF MINNESOTA AND IN WESTERN WISCONSIN. OUR VOLUNTEER OUTREACH STAFF ALSO PROVIDE INFORMATION AND REFERRALS TO 600 PEOPLE ANNUALLY. IN 2019, FELINE RESCUE PARTICIPATED IN SEVERAL COMMUNITY EVENTS, INCLUDING THE CAT VIDEO FESTIVAL AT CHS FIELD AND THE HIGHLAND PARK FESTIVAL IN ST. PAUL.
