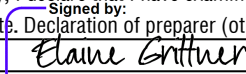

THE SHELTER PROVIDES A SAFE AND NURTURING ENVIRONMENT WHERE CATS RECEIVE ESSENTIAL VETERINARY SERVICES, INCLUDING STERILIZATION SURGERY AND RABIES VACCINATIONS, AND ARE PREPARED FOR ADOPTION. THE SHELTER IS A COMFORTING SPACE FOR THOSE WHO MAKE THE DECISION TO SURRENDER A CHERISHED PET, AND IT'S A WELCOMING SPACE FOR THOSE LOOKING TO BRING HOME A NEW BEST FRIEND. WE ALSO HOST EDUCATIONAL EVENTS TO PROMOTE RESPONSIBLE PET OWNERSHIP AND COMMUNITY INVOLVEMENT. THROUGH OUR SHELTER PROGRAM, WE STRIVE TO CREATE A SAFE TRANSITION FOR CATS AS THEY LOOK FOR A PERMANENT HOME. IN 2024 ALONE, WE HAD 421 INTAKES AND SUCCESSFULLY ADOPTED OUT 434 CATS TO 366 UNIQUE ADOPTERS, REFLECTING OUR COMMITMENT TO FINDING LOVING HOMES FOR EVERY
